## MEMBERSHIP POLICY

Thank you very much for showing interest in becoming a member of the Animal Anti-Cruelty League™. We are always delighted to welcome new members, as members play a vital role in our organisation and they determine who sits on the AACL™ Management Committee.

1. As a charity, the AACL™ exists to further its aims of promoting Care & Protection to animals, in South Africa and this policy aims to ensure that any and all memberships will benefit the charity and its work.
2. As such, membership is not an automatic entitlement; and any decision regarding the acceptance of a membership application ultimately lies with the AACL™ Management Committee. Decisions are made under the AACL™ rules and on a basis of what is in the best interests of the charity.
3. The Management Committee may for example refuse an application or terminate an existing membership where a person's real reason for joining the AACL™ is to promote a purpose other than animal welfare.
4. When adopting an animal from the AACL™ an adopter automatically becomes a member of the AACL™ (branch where the adoption has taken place). Such a membership is valid for 1 year. Such a member shall have full voting rights.
5. Members should acquaint themselves with the differences between animal welfare and animal rights, as they are different and the AACL™ is neither an animal rights nor a pro-life organisation.
6. We treat all members and applicants fairly and all information provided on application for membership will be taken in consideration.
7. Becoming a member of the AACL™, mandates the organisation to always "Speak on behalf of those who cannot speak for themselves".

As a member you will receive our regular ANIMAL TIMES e-NEWSLETTER which will inform you of what we are doing, and you have the right to vote at our AGM provided that you are over 18.
